Approximately 5,780.54± acres of flourishing grass pastures including approximately 437.15± acres of irrigated ground under two Reinke pivots and one Valley Pivot.

LOCATION & ACCESS

The Ellis-Campbell Ranch is located in the northern portion of Goshen County in southeast Wyoming. The property is easily accessed year-round from US Highway 85. To reach the property, travel approximately 0.6 miles south of Jay Em on U.S. Highway 85; turn east onto Road 122 (Prairie Center Road), a well-maintained gravel county road, for approximately 11 miles. Turn north on Van Tassell Road, which is a paved road, continue traveling for approximately 2.3 miles and arrive at Campbell Headquarters. To arrive at the Ellis headquarters, continue traveling north for an additional mile. From Torrington, travel north on Wyoming Highway 159 (Van Tassell Road) for approximately 27 miles to Prairie Center Road. The ranch has easy access to several cities and towns in the four-state area:

The Ellis-Campbell Ranch is a well-watered, highly productive, low overhead farm and grass ranch located in southeastern Wyoming. The ranch consists of approximately 5,780.54± total acres. The property also includes approximately 437.15± irrigated acres which are irrigated via two low-pressure Reinke center pivots and one Valley low-pressure pivot. This is a rare opportunity to own a large, fully improved, heavily sodded farm/ranch. Pride of ownership is shown throughout the property.

The ranch elevations range between 4,519 to 4,800 feet above sea level and is easily accessible year-round via well maintained county road.

MINERAL RIGHTS

Any and all mineral rights associated with the subject property owned by Seller have been severed from the property and are not available.

SOILS

Soils on the ranch consist of primarily loamy soil which produces excellent species of hardy grasses including native gramma grasses, thread leaf sedge, western wheat, intermediate wheat, and some crested-wheat grasses. These soils are predominantly sandier and are more like the sand hills to the east as opposed to gumbo type soils.

CARRYING CAPACITY / RANCH OPERATIONS

The Ellis-Campbell Ranch is in the heart of cattle country which is known for its high-protein hard grass. The property is owner-rated at 300 pairs year-round.

The property historically has been, and is currently being utilized as a cow/calf/yearling operation as well as a hay operation. Cattle are run year-round on the ranch with minimal supplemental feeding due to the abundance of forage available on the winter pastures. The ranch is cross fenced into eight primary pastures and the fences are in excellent condition. Under the current ownership, Ellis-Campbell Ranch boasts weaning weights averaging 500 pounds on heifer calves with the steers weighing in at slightly more than 525 pounds.



With typically open winters and exceptional water development, the current owners are able to reduce the amount of feed and labor needed to run the cattle through the winter months. Three livestock markets in proximity to this ranch are Torrington, Crawford and Gering.

- The Torrington Livestock Markets, located in Torrington, Wyoming, is approximately 66 miles south of the ranch. According to their website at http://www.torringtonlivestock.com/: Torrington Livestock Markets is Wyoming's largest livestock market offering cattle for sale daily by several marketing options; live Cattle Auctions, Video Cattle Auctions & Private Treaty. All classes of cattle are for sale every Friday. Yearling & Calf sales are held every Wednesday, August through March. Special Bred Cow, Pair & Calf sales are held on Mondays as advertised throughout the fall.
- Crawford Livestock Market, Crawford, Nebraska: Fall sales dates at the Crawford Livestock Market are scheduled every Friday with special weigh-up and calf sales dates starting in October. For more information, please visit the Crawford Livestock Market website at https://www.crawfordlivestock.com/.
- Sugar Valley Stockyards, located in Gering, Nebraska is approximately 70 miles southeast. According to their website at https://svstockyards.com/, Sugar Valley Stockyards has multiple sales on Monday throughout the year. A full detailed schedule can be found on their website.

The three pivots on the ranch are currently in production. Two of pivots on the Ellis-Campbell Ranch are Reinke and the third pivot is a Valley pivot. The current owner has recently gone through each of the three pivot systems replacing tires.

The south pivot is 9 years old, and will be planted in beans for the 2025 growing season. There is a cash lease associated with this pivot.

The second pivot, located northwest of the ranch headquarters, irrigates approximately 160± acres and is in a Rye cover crop and will be planted in potatoes for the 2025 growing season. There is currently a cash lease for 2025 associated with the northwest pivot.

The pivot located at the northern end of the ranch is planted in alfalfa, the stand is approximately three years old. The growing season is approximately 130 days long and the owners have harvested up to three cuttings of alfalfa within each growing season.

Electric costs to operate the pivots during the growing season range between \$1,400 to \$1,800 per pivot, per month, depending upon the amount of precipitation received each year.

Note: carrying capacity can vary due to weather conditions, management practices, and type of livestock. Interested parties should conduct their own analysis.





IMPROVEMENTS

The Ellis-Campbell Ranch features two complete sets of improvements located approximately one mile from one another. The first home on the Ellis-Campbell Ranch is a high end custom-built 2,932 sq. ft. 3 bedroom, 2½ bathroom home with a four rail continuous pipe entrance. This home features wood floors, quartz counter tops, Pella windows, gas fireplace, on demand heat, LED lights, stainless-steel appliances. The home is plumped for a water softener, however one is not currently being used. There is an attached two-car garage. The home has beautiful views of the Rawhide Buttes and Laramie Peak.

Outbuildings near the home include:

The second set of improvements on the Ellis-Campbell Ranch include a 1,743 sq. ft. home featuring three bedrooms and one and a half bathrooms. The home has a one car garage along with a small basement. Other features include propane heat, central air, water softener, and two submergible wells which service the home, corrals, outbuildings, and shop.

RECREATION & WILDLIFE

The Ellis-Campbell Ranch offers excellent hunting opportunities for trophy mule deer, white tail deer, antelope, sharp tail grouse, and other upland bird species. Wildlife thrives in the three irrigated pivots and dryland vegetation. Ellis/Campbell Ranch offers unlimited opportunities for the outdoor enthusiast.

WATER RESOURCES

A summary of the water rights of Ellis-Campbell Ranch is included in this brochure. An updated search of the surface and ground water rights for the ranch will be completed by an independent consultant. Upon acceptance of a purchase, the results of the completed search will be made available to the buyer during the inspection period. In the event of a sale, all water rights permitted and adjudicated to the property shall be transferred to the buyer.

There are four reliable, working windmills which provide excellent quality and quantity of water for livestock and wildlife. In addition to the windmills, there are four submersible wells, two miles of underground pipeline and five solar wells.

The two Reinke low-pressure center pivot and one Valley pivot irrigate approximately 437.15± acres of ground and each pivot is provided with water from its own irrigation well. Recent upgrades to the pivots include new tires and gearboxes.

Several of the wells located on the Ellis-Campbell Ranch have 10,000-15,000 gallon storage tanks.


All the irrigation wells are located in the Arikaree Aquifer.

CLIMATE



STATE OF WYOMING

Wyoming is a state that offers an incredible diversity of activities. geography, climate, and history. Just a territory in 1869, Wyoming became the state in 1890. The state's population is 563,626, and provides a variety of opportunities and advantages for persons wishing to establish residency.

Wyoming's energy costs are the second lowest in the nation, and the cost of



living index is below the national average. Wyoming ranks among the top ten in the entire United States for educational performance. There is no state income tax, and Wyoming offers an extremely favorable tax climate:

According to Michael B. Sauter, Alexander E. M. Hess, Samuel Weigley, and Ashley C. Allen of 24/7 Wall Street, Wyoming is a model of good management and a prospering population. The state is particularly efficient at managing its debt, owing the equivalent of just 20.4% of annual revenue in fiscal 2010. Wyoming also has a tax structure that, according to the Tax Foundation, is the nation's most-favorable for businesses - it does not have any corporate income taxes. The state has experienced an energy boom in recent years. The mining industry, which includes oil and gas extracting, accounted for 29.4% of the state's GDP; more than in any other state. As of last year, Wyoming's poverty, home foreclosure, and unemployment rates were all among the lowest in the nation.





STATE LOCATION MAP



As a Buyer's Agent, the Broker has duties to disclose to the Buyer certain information; therefore, the Seller should not tell the Broker any information which the Seller does not want shared with the Buyer.

Intermediary. (Requires written agreement with Seller and/or Buyer)

The Intermediary relationship is a non-agency relationship which may be established between a Broker and a Seller and/or a Broker and a Buyer. A Seller may choose to engage a Broker as an Intermediary when listing a property. A Buyer may also choose to engage a Broker as an Intermediary. An Intermediary shall not act as an agent or advocate for any party and shall be limited to providing those services set forth below. Wyo. Stat. § 33-28-305.

As an Intermediary (Non-Agent), Broker will not represent you or act as your agent. The parties to a transaction are not legally responsible for the actions of an Intermediary and an Intermediary does not owe the parties the duties of an agent, including the fiduciary duties of loyalty and fidelity. Broker will have the following **obligations** to you:

- perform the terms of any written agreement made by the Intermediary with any party or parties to the transaction;
- exercise reasonable skill and care;*

- advise the parties to obtain expert advice as to material matters about which the Intermediary knows but the specifics of which are beyond the expertise of the Intermediary;*
- present all offers and counteroffers in a timely manner;*
- account promptly for all money and property the Broker received;*
- keep you fully informed regarding the transaction;*
- obtain the written consent of the parties before assisting the Buyer and Seller in the same real estate transaction as an Intermediary to both parties to the transaction;
- assist in complying with the terms and conditions of any contract and with the closing of the transaction;*
- disclose to the parties any interests the Intermediary may have which are adverse to the interest of either party;
- disclose to prospective Buyers, known adverse material facts about the property;*
- disclose to prospective Sellers, any known adverse material facts, including adverse material facts pertaining to the Buyer's financial ability to perform the terms of the transaction;*
- disclose to the parties that an Intermediary owes no fiduciary duty either to Buyer or Seller, is not allowed to negotiate on behalf of the Buyer or Seller, and may prohibited from disclosing information about the other party, which if known, could materially affect negotiations in the real estate transaction.

As Intermediary, the Broker will disclose all information to each party, but will not disclose the following information without your informed consent:

- the motivating factors for buying or selling the property;
- that you will agree to financing terms other than those offered, or
- any material information about you, unless disclosure is required by law or if lack of disclosure would constitute dishonest dealing or fraud.

<u>Change From Agent to Intermediary – In – House Transaction</u>

If a Buyer who has signed a Buyer Agency Agreement with the Broker wants to look at or submit an offer on property Broker has listed as an agent for the Seller, the Seller and the Buyer may consent in writing to allow Broker to change to an Intermediary (non-agency) relationship with both the Buyer and the Seller. Wyo. Stat. § 33-28-307.

An established relationship cannot be modified without the written consent of the Buyer or the Seller. The Buyer or Seller may, but are not required to, negotiate different commission fees as a condition to consenting to a change in relationship.

<u>Designated Agent.</u> (requires written designation by the brokerage firm and acknowledgement by the Buyer or Seller)

A designated agent means a licensee who is designated by a responsible broker to serve as an agent or intermediary for a Seller or Buyer in a real estate transaction. Wyo. Stat. \S 33-28-301 (a)(x).

In order to facilitate a real estate transaction a Brokerage Firm may designate a licensee as your agent or intermediary. The Designated Agent will have the same duties to the Buyer and Seller as a Buyer's or Sell's Agent or Intermediary. The Broker or an appointed "transaction manager" will supervise the transaction and will not disclose to either party confidential information about the Buyer or Seller. The designation of agency may occur at the time the Buyer or Seller enters into an agency agreement with the Brokerage Firm or the designation of agency may occur later if an "in house" real estate transaction occurs. At that time, the Broker or "transaction manager" will immediately disclose to the Buyer and Seller that designated agency will occur.

Duties Owed by An Agent But Not Owed By An Intermediary.

WHEN ACTING AS THE AGENT FOR ONE PARTY (EITHER BUYER OR SELLER), BROKER HAS FIDUCIARY DUTIES OF UTMOST GOOD FAITH, LOYALTY, AND FIELITY TO THAT ONE PARTY. A BROKER ENGAGED AS AN INTERMEDIARY DOES NOT REPRESENT THE BUYER OR THE SELLER AND WILL NOT OWE EITHER PARTY THOSE FIDUCIARY DUTIES. HOWEVER, THE INTERMEDIARY MUST EXERCISE REASONABLE SKILL AND CARE AND MUST COMPLY WITH WYOMING LAW. AN INTERMEDIARY IS NOT AN AGENT OF ADVOCATE FOR EITHER PARTY. SELLER AND BUYER SHALL NOT BE LIABLE FOR ACTS OF AN INTERMEDIARY, SO LONG AS THE INTERMEDIARY COMPLIES WITH THE REQUIREMENTS OF WYOMING'S BROKERAGE RELATIONSHIPS ACT. WYO. STAT. § 33-28-306(a)(iii).

THIS WRITTEN DISCLOSURE AND ACKNOWLEDGMENT, BY ITSELF, SHALL NOT CONSTITUTE A CONTRACT OR AGREEMENT WITH THE BROKER OR HIS/HER FIRM. UNTIL THE BUYER OR SELLER EXECUTES THIS DISCLOSURE AND ACKNOWLEDGEMENT, NO REPRESENTATION AGREEMENT SHALL BE EXECUTED OR VALID. WYO. STAT. § 33-28-306(b).

NO MATTER WHICH RELATIONSHIP IS ESTABILSHED, A REAL ESTATE BROKER IS NOT ALLOWED TO GIVE LEGAL ADVICE. IF YOU HAVE QUESTIONS ABOUT THIS NOTICE OR ANY DOCUMENT IN A REAL ESTATE TRANSACTION, CONSULT LEGAL COUNSEL AND OTHER COUNSEL BEFORE SIGNING.

The amount or rate of a real estate commission for any brokerage relationships is not fixed by law.
