IN CONSIDERATION of the unitual advantages to be derived therefrom, the undersigned, Charles F. Heyes, for himself, his being, executors, administrators and assigns, covenants and agrees as follows:

- All buildings must be set back fifty (50) feat from the street or road which they face.
- 2. All dwelling houses shall not have less than one thousand (1,000) square feet of heated floor space.
- J. To characters or offensive trace shall be carried on upon any lot, nor shall saything be deno thereon which may be or become an anneyance or mulsance to the neighborhood.
- h. No bogs; cows, goats or other like animals may be kept on any of these lote.
- 5. No building shall be erected on any lot nearer than ten (10) feet to any side lot line.
- 6. We septic tank shall be built on any lot without meeting the approval of the State Board of Health of South Carolina.
- 7. No execute blocks shall be used in the construction of any house built on any of this property whereby they may be visible.
  - 8. We house trailers may be located on any of this property.
- 9. We become of an inferior quality or "shell home" shall be built or located on this property.
- 10. Any outbuildings of any type or nature shall be constructed with the same type and quality material used in the dwelling house.

11. No imitation brick siding shall be placed on any house or building located in this subdivision.

12. These restrictions may be assended at any time by a duly executed and recorded instrument of 60% or more of the recorded owners of lots in this subdivision.

13. Invalidation of any one or more of these covenants and restrictions shall in no wise affect any of the other covenants and restrictions, and they shall remain in full force and effect.

lh. All persons hereafter encepting coveyances of any of the lots shown on the plat referred to shall encept the same upon and subject to the above enumerated conditions, covenants and restrictions which are to be deemed covenants running with the land, and binding upon the grantees, their hairs and assigns; and violation of any of the conditions or restrictions shall vest in the Granter, his successors and assigns, the right of electment in suits in law or equity against my person or persons violating or attempting to violate any condition, or restriction, either to restrain such violation or to recover damages.
