

This balance of water, timber, and food creates a habitat teaming with whitetail deer and eastern wild turkeys.

The property boasts an impressive 87% uplands acreage, along with an internal road system that stretches over 2 miles. The northern boundary of the property directly fronts Old Kirkland Road, which connects to Highway 280 and provides convenient access to the cities of Vidalia and Reidsville. This property would make an excellent country homesite that guarantees secluded privacy and plenty of acreage for your enjoyment. The property also has a high soil integrity suited for timber and agricultural production. At the property's geographical center is a concentration of productive Tifton soils that offer agricultural upside. This fertile acreage could be converted into a bird field, an additional food source for the deer, or transitioned back into conventional agriculture. 
