

## **Woodbine Acreage**

Woodbine Acreage offers 88 total acres with more than 20 acres of potentially developable land that should have accessible sewer and water from the city of Woodbine.

This property consists of two tax parcels, with one parcel located inside the Woodbine city limits. It sits just south of town on the east side of US Highway 17 and extends to 17th East Street. With more than 20 acres of land suitable for development and access to city sewer and water, the property is well-suited for single-family or multi-family projects, subject to proper zoning approvals. Timber on the tract is currently under contract and scheduled to be harvested by January 2027. The highest and best use includes opportunities for small developers or buyers seeking acreage that provides both privacy and convenience.

Woodbine Acreage is positioned at the south end of the historic city of Woodbine, Georgia, the county seat of Camden County. The county is home to the Kings Bay Naval Submarine Base and Cumberland Island National Seashore. This coastal region features scenic marshland views, access to intercoastal waterways, and close proximity to area beaches. Woodbine offers central access to Brunswick and Kings Bay along Interstate 95, while Jacksonville, Florida is only 45 minutes away. Jekyll Island, St. Simons Island, Jacksonville's beaches, the Jacksonville Zoo, and Okefenokee State Park are all within easy driving distance. The property is located at the corner of East 17th Street and US Highway 17 in Woodbine, Georgia.




